

**PETITION TO THE HOUSE OF REPRESENTATIVES**

**TO THE HONOURABLE THE SPEAKER AND MEMBERS OF THE HOUSE OF REPRESENTATIVES**

This petition of concerned subjects of Australia draws to the attention of the House:

**REASONS:**

Since 1973, changes to Oaths of Office and Royal Titles (via the Australia Act 1986 and Oaths Acts) were enacted without the direct consent of the people via a Section 128 referendum. We believe this has weakened the legal bond between officials and the Commonwealth of Australia Constitution Act 1900 (Imp), leading to a lack of transparency and a “broken motor” in our political system.

**REQUEST FOR ACTION:**

We therefore ask the House to initiate a formal Parliamentary inquiry into the constitutional validity of current Oaths of Office, and to seek a reference to the High Court of Australia under **Section 77 of the Commonwealth Constitution of Australia Act 1900 (Imp)** to clarify the relationship between **Section 51 (xxxviii)** and **Section 128**. We request that this inquiry ensure every Official is legally bound to the people they serve through valid Oaths of Office. And that a structured review period be established to validate legislation passed during the period of unconfirmed authority.

## **Instruction sheet:**

I will be making a copy of each petition so as you are aware, the reason for this is, these Petitions form a legal paper trail that can be used in court proceedings, there will be a High Court Challenge being lodged hopefully by April 2027 if not beforehand, also depending on numbers of this petition. The brief of evidence to be relied upon is currently being put together leaving no stone untuned.
